### CopySMARTRobie® Supplementary Terms & Conditions as at 21 October 2025

These Supplementary Terms & Conditions ("Supplement") apply to your subscription and use of CopySMARTRobie® (the "Service") provided by TradeVSA Systems Sdn Bhd ("TradeVSA") and are supplemental to the SMARTRobie® Terms & Conditions ("Main Terms"). Capitalised terms not defined in this Supplement have the meanings given in the Main Terms. In the event of any inconsistency, the Main Terms prevail.

### 1. Nature of Service

- 1.1 CopySMARTRobie® is offered as a forward-test simulation environment.
- 1.2 Each user is provided a virtual fund of USD \$10,000 for simulated trades.
- 1.3 The simulation mirrors the price movements and trading environment of U.S. equities market but does not involve real money, custody of client assets, or actual execution on any exchange.
- 1.4 Simulated trades are generated and executed automatically by the CopySMARTRobie®\_60 Bot.
- 1.5 CopySMARTRobie® is strictly an educational and illustrative tool and is not intended to constitute investment advice or a recommendation to buy or sell securities. For the avoidance of doubt, while TradeVSA is licensed by the Securities Commission Malaysia to provide digital investment advice, CopySMARTRobie® is provided as a simulation and does not create an adviser–client relationship.

# 2. Eligibility & Access

- 2.1 To access CopySMARTRobie®, you must:
  - (i) hold a valid SMARTRobie® account; and
  - (ii) subscribe via the SMARTRobie® App's Market Place.
- 2.2 By subscribing, you confirm that you are a Malaysian citizen or lawful resident of Malaysia, and you are solely responsible for ensuring that your use of CopySMARTRobie® complies with applicable Malaysian laws and regulations.

# 3. Subscription

- 3.1 CopySMARTRobie® is available by subscription in the SMARTRobie® App's Market Place.
- 3.2 Promotional subscription: RM29.90 for three (3) months, inclusive of a complimentary three (3) month All Exchange Monthly Pass for SMARTRobie® (regular price RM150). All prices are inclusive of applicable Malaysian taxes.
- 3.3 Subscriptions are one-time purchases for the stated period and do not automatically renew.
- 3.4 Subscriptions are non-refundable.
- 3.5 Promotional offers are time-limited and may be withdrawn or changed by TradeVSA at its discretion.

#### 4. Simulation Parameters

- 4.1 CopySMARTRobie® provides each user with a virtual balance of USD \$10,000 to conduct forwardtest simulations.
- 4.2 All trades, signals, and allocations are simulated only and do not involve real money, brokerage accounts, or execution on any exchange.
- 4.3 The simulation mirrors price changes and corporate actions of U.S. equities markets, but it does not fully replicate all real-world trading conditions (such as brokerage fees, taxes, liquidity, or execution delays). Actual trading results may differ materially.
- 4.4 Once the virtual balance is exhausted, no further simulated trades can be executed.

### 5. Intellectual Property

- All rights, title, and interest in CopySMARTRobie®, including the CopySMARTRobie®\_60 Bot algorithms, software, design, and content, are owned by or licensed to TradeVSA.
- 5.2 You must not copy, reproduce, reverse-engineer, decompile, adapt, translate, create derivative works from, distribute, sell or otherwise exploit any part of the Service or its contents without TradeVSA's prior written consent.
- 5.3 The Intellectual Property provisions of the Main Terms apply to CopySMARTRobie®.

- 6.1 Your use of CopySMARTRobie® will generate additional data (including simulated trades and performance history).
- 6.2 Such data will be processed in accordance with the SMARTRobie® Privacy Policy and in compliance with the Personal Data Protection Act 2010.
- 6.3 By using CopySMARTRobie®, you consent to TradeVSA's collection, use and processing of this data for service provision, analytics, product improvement and other legitimate purposes described in the Privacy Policy.

- 7.2 CopySMARTRobie® is a simulation only; It does not execute real trades and does not guarantee profit or future performance.
- 7.3 Past performance is not an indicator of future performance, investing and trading in securities involve significant risk, including the risk of loss of capital. Your use CopySMARTRobie® at your own risk and for educational purposes only.
